

Angling International LIVE EXHIBITION TERMS AND CONDITIONS

At Incheba Expo Bratislava, Viedenská cesta 3250/5, 851 01 Petržalka, Slovensko 26- 28 June 2025.

General rules

1. Definitions

- i) 'The Exhibition' means Angling International LIVE to be held on 26th, 27th and 28th June 2025 at Incheba Expo Bratislava, Viedenská cesta 3250/5, 851 01 Petržalka, Slovensko.
- ii) 'The Organiser' means Angling International LIVE Team. (Anglingtrade Ltd. H-1201 Budapest, Helsinki road 74.)
- iii) 'The Exhibitor' means any company, firm or legal entity that has ordered display space at the Exhibition.

2. Shell Scheme / Space Only

- i) Shell Scheme price includes walls, carpet, name board and 1 spotlight per 4 sqm, exhibitor badges.
- ii) Space Only price includes marked-out floor area and exhibitor badges. All Exhibitors who book SPACE ONLY sites must supply a drawing of their stand design, including electricity connection points, to the Organiser at least 8 weeks before the first day of the exhibition.

3. Payment Terms

Stands booked from 28th February 2025 onwards - 100% balance due 14 days net payable to Anglingtrade Ltd. Late payment for the delay period with 20% late payment interest. Service is only available after a paid invoice

4. Opening Hours

- i) The Exhibition will be open to visitors at the advertised stated times each day.
- ii) The Exhibitor undertakes to have exhibits on display, in good order, and adequately attended during these periods.

5. Display Space

- i) The Organiser reserves the right to relocate the Exhibitor to a stand other than that specified in the Angling International LIVE account and the digital floorplan.
- ii) Exhibitors may only sub-let part of their stand to companies for whom they act as selling agents or distributors. Exhibitors are not permitted to sub-let their entire stand to another company.
- iii) Exhibits must be completely installed by 18.00hrs on June 25th, 2025 and removed by 16.00 on June 29th 2025.
- iv) The Organiser reserves the right to relocate stands if necessary.
- v) The Exhibitor agrees not to display or advertise goods or services other than those manufactured or carried by the Exhibitor in the normal course of business.
- vi) Exhibitors may only display fishing tackle or products directly related to fishing such as clothing, tents, seats etc or fishing tackle publications. Display of any other items will be at the discretion of the Organiser.
- vii) No explosive or inflammable materials are allowed on the exhibition premises and Exhibitors agree to comply with all instructions given by any relevant authorities to avoid the risk of fire or any other risk.
- viii) There can be only one company in one exhibition place. In case of multi exhibitors in one booth, organizer can close the booth and refuse the involved companies presence at the show

6. Height Limitations

- i) The height limit on display spaces is 2.5 metres. Any stand over this height requires written approval from the Organiser.
- ii) The height limit on displays or other items is 2.5 metres. Any display over this height requires written approval from the Organiser.

7. Intellectual Property

The Exhibitor must ensure all products/exhibits on the stand do not violate any intellectual property rights, patents, registered models or trademarks. If the Exhibitor is found to be doing so, after verification, the Organiser

has the right to close down the stand with immediate effect, expel the Exhibitor from the show and no refunds will be made.

8. Removal of Exhibits

- i) No exhibits shall be packed, removed or dismantled before the closing of the Exhibition without written consent of the Organiser.
- ii) The Exhibitor will be liable for all storage, removal and handling charges incurred by the Organiser resulting from failure to remove all exhibits and display materials from the halls before 16.00 hrs the day after the Exhibition.
- iii) The Exhibitor must surrender any occupied shell scheme and stand items in the original condition.

9. Cancellation by Exhibitor

- i) Cancellation by February 28th with a 100% refund. A cancellation fee of 50% of the total sum due will be charged for all cancellations made before 30th April, 2024. After that date, no cancellations are acceptable, and no refunds will be made.
- ii) If the Exhibitor does not occupy the space by 19:00 25th June 2025, the Organiser is authorised to occupy the space as it deems to be in the best interests of the exhibition, without in any way releasing the Exhibitor from any responsibility.

10. Exhibition Cancellation, Change of Location, Curtailment or Change of Date of Exhibition

- i) If because of any event outside the Organiser's reasonable control (including without limitation any strike or other industrial action involving the Organiser's workforce) the exhibition or any part thereof is prevented from being held in a particular location or on a particular date, the Organiser shall be entitled in its absolute discretion to cancel, relocate or change the date of all or any part of the exhibition or reduce the planned period for preparation, display or dismantling of the exhibition and in such event any refund of payments to the Exhibitor shall be at the absolute discretion of the Organiser.
- ii) Such refund, if given, shall be such proportionate share of the balance of the aggregate exhibit fees received by the Organiser. Concerning the exhibition as the Organiser thinks fit after deducting expenses incurred by and reasonable compensation for the Organiser. In no case shall the amount of any refund to the Exhibitor exceed the amount paid by the Exhibitor nor shall the Exhibitor be entitled to review or audit any of the Organiser's financial records.
- iii) The Exhibitor as a result of this acknowledges that in the event of the circumstances referred to in 10. i – 10. ii he shall have no right to any refund, damages or expenses.
- iv) If the Organiser cancels the exhibition for commercial reasons, including without limitation lack of support, then all payments made by the Exhibitor to the Organiser will be refunded, but the Exhibitor hereby agrees that in such circumstances he will have no further claim (whether for damages or otherwise) against the Organiser.
- iv)** If the Organiser cancels the exhibition for commercial reasons, including without limitation lack of support, the Organiser will deduct its own service fee before refunding the remaining payments made by the Exhibitor. Furthermore, in cases where the Exhibitor has benefited from discounted rates (e.g., Early Bird or other discounts), the Organiser will refund only 50% of the exhibition fee paid. The Exhibitor hereby agrees that in such circumstances, they will have no further claim (whether for damages or otherwise) against the Organiser.

11. Limitation of Liability

- i) The Exhibitor acknowledges that the Organiser shall not be held responsible for the failure of any number of attendees to attend the exhibition for any reason beyond the reasonable control of the Organiser.
- ii) Any application for stand space or any acceptance thereof by the Organiser shall not be conditional on the presence or location of any other Exhibitor at the exhibition or any other exhibition.
- iii) The Exhibitor at this moment acknowledges that in the event of the circumstances referred to in 11. i – 11. ii he shall have no right to any refund, damages or expenses.

12. Exhibitor Qualification

- i) All European companies who are in the fishing industry can exhibit at Angling International LIVE without any limitation.

- ii) All non-European companies who wish to exhibit will only be accepted if they paid the 1.500 EUR European Market Contribution Fee. (EMCF) Changing the EMCF is the sole discretion of the Organiser, EMCF must be paid where appropriate.
- iii) The Exhibitor agrees to abide by the general rules and regulations of the Organiser and hall authorities. These are listed in the Exhibitor Manual.
- iv) The Organiser reserves the right to reject any application and to cancel bookings at any time for failure to conform to rules and regulations.

13. Indemnity

- i) Whilst the Organiser will take every care all exhibits are shipped, delivered and handled at the Exhibitor's risk and expense.
- ii) The Exhibitor agrees to indemnify the Organiser against all costs, expenses, charges, losses or claims in consequence of damage to property or injury to members of the public or any other person and any consequential loss caused by or as a result of the act, default or negligence of the Exhibitor or his employees or any other person or persons under his direction.

14. Insurance

- i) To protect the interest of the Exhibitor it is recommended that Exhibitors have minimum insurance of 1,000,000 Euro.
15. Law Applicable These Terms and Conditions shall be subject to English Law and the parties hereto submit to the non-exclusive jurisdiction of the Hungarian Court.

15. General acceptance

Exhibitors accept these Terms and Conditions by marking it read on their Angling International LIVE Account after registration.
